The franchise offered is for the right to operate a “DMK Burger Bar” franchised business in either a food court location or an inline location offering grass-fed Angus beef burgers, turkey and vegetarian burgers, gourmet sandwiches, hand-cut fries, salads, house-made milkshakes and sodas, and other food and beverage products and services, along with certain food items utilizing the proprietary system for DMK Burger Bars.

The total investment necessary to begin operation of a DMK Burger Bar franchise ranges from \$318,500 to \$469,000 for a food court location, and \$484,000 to \$769,500 for an inline location. This amount includes up to \$30,000 that must be paid to the franchisor or its affiliate. If you want development rights, you must pay the franchisor or its affiliate a development fee equal to \$30,000 (the initial franchise fee for the first DMK Burger Bar) plus a deposit of \$12,000 for the second DMK Burger Bar you will develop and each additional DMK Burger Bar you will develop (you must develop a minimum of 2 DMK Burger Bars).

This Disclosure Document summarizes certain provisions of your Franchise Agreement and other information in plain English. Read this Disclosure Document and all accompanying agreements carefully. You must receive this Disclosure Document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**

OUT-OF-STATE ARBITRATION OR LITIGATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES. IT MAY COST YOU MORE TO ARBITRATE OR LITIGATE WITH US IN THE STATE OF ILLINOIS THAN IN YOUR OWN STATE.

3. WE WERE FORMED IN SEPTEMBER 2016. AS A RESULT, WE ONLY HAVE A BRIEF OPERATING HISTORY TO ASSIST YOU IN DETERMINING WHETHER OR NOT TO MAKE THIS INVESTMENT.
4. YOU WILL NOT RECEIVE AN EXCLUSIVE FRANCHISE TERRITORY. YOU MAY FACE COMPETITION FROM OTHER FRANCHISEES, FROM OUTLETS WE OR OUR AFFILIATES OWN, OR FROM OTHER CHANNELS OF DISTRIBUTION OR COMPETITIVE BRANDS WE OR OUR AFFILIATES CONTROL.
5. THERE MAY BE OTHER RISKS CONCERNING THIS FRANCHISE.

We use the services of one or more FRANCHISE BROKERS or referral sources to assist us in selling our franchise. A franchise broker or referral source represents us, not you. We pay this person a fee for selling our franchise or referring you to us. You should be sure to do your own investigation of the franchise.
