We offer franchises for the operation of "Dr G's WeightLoss & Wellness" centers, which may be operated from a retail storefront located in a strip mall, shopping center or other similar location ("Dr G's Center") While the "Dr G's WeightLoss & Wellness" business model requires that you engage the services of a licensed M D at every location, you will not be permitted to engage in the practice of medicine unless you are a licensed medical doctor in the state in which your Dr G's Center is located

The total investment necessary to begin operation of a Dr G's WeightLoss & Wellness Center franchised business is \$142,700 to \$222,300 if you operate from a Co-Located Facility and \$196,350 to \$478,100 if you operate from a Stand-Alone Facility This includes approximately \$108,800 to \$131,300 that must be paid to the franchisor if you operate from a Co-Located Facility, and approximately \$128,600 to \$306,600 that must be paid to the franchisor if you operate from a Stand-Alone Facility

We are offering to certain qualified people the right to become an Area Director The total investment necessary to begin operating as a Dr G's Area Director will range from \$250,000 to \$2,000,000 depending on the size of the development area The estimated initial investment will vary based on the number of Dr G's Centers to be developed. An Area Director must own and operate one Dr G's Center

This disclosure document summarizes certain provisions of your Franchise Agreement and other information in plain English Read this disclosure document and all accompanying agreements carefully You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale Note, however, that no government agency has verified the information contained in this document
