Dr Pave Worldwide, LLC, a Delaware limited liability company, offers franchises for the operation of businesses that use high-efficiency portable equipment (the "Heatwurx Branded Equipment") and a patent-pending proprietary asphalt preservation process that recycles existing asphalt (the 'Heatwurx Process") to repair, maintain and preserve roadways under the trade names and service marks 'Heatwurx' and "Dr Pave" and other related trademarks, service marks, logos and commercial symbols

If we grant you the opportunity to purchase a Dr Pave franchise, you will sign a Franchise Agreement to operate a Dr Pave franchised business in a single territory. The total investment necessary to begin operations of a single Dr Pave franchised business ranges from approximately \$126,850 to \$298,600. This includes \$108,600 that must be paid to us

This Disclosure Document summarizes certain provisions of your Franchise Agreement and other information in plain English. Read the Disclosure Document and all accompanying agreements carefully. You must receive this Disclosure Document at least 14 calendar days before you sign a binding agreement with, or make any payments to the Franchisor or an affiliate in connection with the proposed franchise sale. Note, however, that no government agency has verified the information contained in this document.
