As a franchisee you will operate a business that provides custom repair and recoloring of vinyl (including vinyl siding), leather, fabric and plastic covered surfaces of automobiles, boats and other motor vehicles, pinstriping and other automotive after-market products operated from a mobile van mainly for commercial markets. The total investment necessary to begin operations of a Dr. Vinyl franchise is between \$41,320 and \$71,500. This includes \$24,500 that must be paid to the franchisor or affiliate.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. Note, however, that no governmental agency has verified the information contained in this document.
