As a franchisee you will perform residential and commercial bathroom, kitchen and other interior remodeling as well as remodeling alternatives, including, cabinet refacing and the installation of tubliner and wall systems, and perform related services and sell related products. You will focus primarily on interior remodeling, but will also provide exterior remodeling and restoration projects as needed.

The total investment necessary to begin operation of a DREAMMAKER BATH & KITCHEN BY WORLDWIDE® franchise ranges from \$95,950 to \$244,650. This includes \$55,750, plus \$185 per 1,000 population for additional territory, that must be paid to the franchisor or affiliate. See Item 5.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale.
