The franchisor is offering franchises for the operation of a quick-serve, casual restaurant featuring hamburgers, fries, shakes and related menu items. The initial franchise fee is \$35,000 for the first franchise and \$25,000 for each subsequent franchise. The total estimated initial investment necessary to begin operation of a Drifter's Hamburgers franchise is between \$130,000 and \$511,000. This amount includes \$35,000 that must be paid to the franchisor or its affiliates. The initial investment estimate is approximate and initial fees are more fully described in Items 5, 6, and 7 of this Disclosure Document.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English Read this disclosure document and all accompanying agreements carefully You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale **Note, however, that no governmental agency has verified the information contained in this document**

The terms of your contract will govern your franchise relationship Don't rely on the disclosure document alone to understand your contract Read all of your contract carefully Show your contract and this disclosure document to an advisor, like a lawyer or an accountant
