The franchise described is known as “DripDoctors® (“DripDoctors”). DripDoctors Holdings offers and sells single-unit franchise locations, or “Clinics;” these Clinics, owned and operated by DripDoctors franchisees, provide IV Vitamin Therapy, Hydration, Anti-Aging, Bio-Identical Hormone Replacement, Weight Loss and Cosmetic Enhancements to clients in a clinic or concierge setting through licensed medical professionals, specifically physicians, surgeons, registered nurses, naturopathic doctors, and physician assistants.

The total investment necessary to begin operation of a DripDoctors Single Unit franchised business is \$199,700 to \$411,500. This includes an Initial Fee of \$52,500.00 to secure your chosen Territory which includes a \$15,000 Preliminary Agreement Fee that must be paid to Us. The total investment necessary to begin operation of a DripDoctors Area Development franchise business is \$252,200 to \$516,500. This includes the Initial Fee for the first unit and the 50% payment of all additional Initial Fees that must be paid to Us at the time You sign the initial Franchise Agreement.

This Disclosure Document summarizes certain provisions of your Franchise Agreement and other information in plain English. Read this Disclosure Document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar-days before You sign a binding agreement with, or make any payment to Us or an affiliate in connection with the proposed franchise sale. **Note however, that no governmental agency has verified the information contained in this document.**

5. **THIS NEW FRANCHISOR HAS BEEN IN BUSINESS FOR SUCH A SHORT PERIOD OF TIME THAT ITS FRANCHISES ARE A HIGHER RISK INVESTMENT THAN FRANCHISORS WITH A LONGER-TERM OPERATING HISTORY.**
6. **THE TERRITORY IS NOT EXCLUSIVE. YOU MAY FACE COMPETITION FROM OTHER FRANCHISEES, FROM FRANCHISOR OWNED OUTLETS OR FROM OTHER CHANNELS OF DISTRIBUTION OR COMPETITIVE BRANDS FRANCHISOR CONTROLS.**
