The franchise offered is one of three models, the DRNK brand is a traditional quick service beverage concept where customers can order from the diverse menu of hot and cold coffees and teas QWENCH is a quick service juice and smoothie bar which offers healthy beverages created using natural ingredients such as raw vegetables and fruits The third model offered is a combination of the two brands under one roof with a co-branded presentation Locations for all three concepts will range in size from 900 to 1,700 square feet in size depending on the market and model

The total investment necessary to begin operation of a DRNK coffee + tea[®] franchise is \$254,300 to \$443,300 This includes the \$25,000 - \$35,000 franchise fee that must be paid to the Franchisor or an affiliate
