The franchise offered is for a full-service restaurant offering chicken wings with proprietary sauces and dressings, appetizers, burgers, sandwiches, soft drinks, beer and wine. A Duff's Famous Wings restaurant offers lunch and dinner menus for dine-in or take-out, and operates using the franchisor's proprietary recipes, formulae, techniques, trade dress, trademarks and logos.

The total investment necessary to begin operation of a Duff's Famous Wings franchise is \$435,325 to \$972,323. This includes between \$30,390 to \$33,730 that must be paid to the franchisor and/or its affiliate, as appropriate. Please see Items 5 and 7 for additional details.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive the disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no government agency has verified the information contained in this document.**
