We offer franchises for the operation of fast casual restaurants serving fresh, high quality dumplings using proprietary recipes and preparation methods. All of our dumplings are cooked to order for our quests

We also offer a multi-unit franchise under which you agree to open and operate a specified number of DumplingGo restaurants over an agreed period of time within an agreed geographic area

The total investment necessary to begin operation of a DumplingGo restaurant franchise is \$161,000 to \$600,000. This includes \$45,000 to \$176,000 that you must pay to us or our affiliate.

If you sign a multi-unit agreement for the development of three to five units, your total initial investment will be \$186,000 to \$650,000. This includes \$70,000 to \$226,000 that you must pay to us or our affiliate. The total initial investment for the multi-unit agreement includes the total initial investment necessary to begin operation of your first DumplingGo restaurant franchise.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. Note, however, that NO GOVERNMENTAL AGENCY HAS VERIFIED THE INFORMATION CONTAINED IN THIS DOCUMENT.
