## FRANCHISE DISCLOSURE DOCUMENT

The franchisor's name is Dynaco Franchising, Inc. It is a California corporation. Its principal business address is 7050 N. Fresno St., #210, Fresno, California 93720, telephone number (559) 485-8520.
