

This Franchise Disclosure Document ("FDD") describes the Young Engineers Program (" e^2 Young Engineers") franchise concept that offers courses for children and adults to learn math, physics, machine and software engineering, by playing! The services offered include project and educational based services utilizing proprietary course material and LEGO[®] bricks, with additional services such as educational workshops and seminars These services can be offered in schools, educational centers, colleges and/or community centers as part of student programs and activities for children and youth, as well as via the internet This FDD offers to you two (2) types of franchises (1) an Individual Unit Franchise ("Individual Unit Franchise"), or (11) to qualified persons, the exclusive right to develop or refer others to develop an agreed upon number of e^2 Young Engineers franchises within a defined area ("Master Franchise")

The total investment necessary to begin operation of an e^2 Young Engineers franchised business is estimated at \$32,400 to \$55,183 This includes a \$20,000 initial franchise fee that must be paid to us or our affiliate The total investment necessary to begin operation of a Master Franchise is \$30,000 to \$60,000 plus a Development Fee that is negotiated by you and us Master Franchisees will pay reduced initial franchise fees as described by Item 5

This Disclosure Document summarizes certain provisions of your franchise agreement and other information in plain English Read this Disclosure Document and all accompanying agreements carefully You must receive this Disclosure Document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in

connection with the proposed franchise sale Note, however, that no governmental agency has verified the information contained in this document
