As an EarthBar® franchisee, your store will offer a selective line of supplements, including USDA certified organic multi-vitamin pack. We also offer organic super foods, wild-crafted herbal extracts, raw protein powders, probiotics and enzymes, and nutraceuticals

The total investment necessary to begin operation of a single EarthBar® retail store ranges from \$241,500 to \$400,000. This includes \$30,000 that must be paid to us as a franchise fee, and \$25,000 to \$50,000 that must be paid to us or our affiliate for the initial inventory of Proprietary Products.
