Ecowash Mobile USA Inc. ("Ecowash") offers master license businesses ("Master Businesses") that operate company-owned Ecowash Mobile units and offer, sell, and support Ecowash Mobile franchises within a defined territory. Ecowash Mobile franchises ("Franchised Businesses") and company-owned units provide waterless car cleaning and polishing services from mobile units ("Mobile Units") or fixed locations ("Fixed Units"). The total investment necessary to begin operation of a Master Business ranges from \$305,200 to \$322,800 for a business operating one company-owned Mobile Unit. This includes \$294,000 that must be paid to Franchisor for your initial master license fee and your Opening Package payment.

This Disclosure Document summarizes certain provisions of your Master License Agreement and other information in plain English. Read this Disclosure Document and all accompanying agreements carefully. You must receive this Disclosure Document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the master licensor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**

The terms of your contract will govern your franchise relationship. Don't rely on the Disclosure Document alone to understand your contract. Read all of your contract carefully. Show your contract and this Disclosure Document to an advisor, like a lawyer or an accountant.
