The franchise is to operate a business under EDIBLE ARRANGEMENTS®, EDIBLE TO GO®, EDIBLE®, and other trademarks that sells sculpted fruit floral arrangements, gift baskets made with fresh fruit, chocolate-covered fruit, fruit smoothies, fruit salads, fruit and yogurt products, and other chocolate and fruit-related products.

The total investment necessary to begin operation of an EDIBLE ARRANGEMENTS® Business ranges from \$195,450 to \$327,650. This includes between \$52,495 and \$88,500 that must be paid to the franchisor or affiliate.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**
