The standard franchise offered by EO Franchising, LLC ("EOF") as a franchisor is the right and license to operate an EDUCATIONAL OUTFITTERS store specializing in the sale of school uniforms and dress code apparel at a specific location.

The total investment necessary to begin operation of an EDUCATIONAL OUTFITTERS franchise ranges from \$93,200 to \$201,950, excluding land and new building costs. This includes the initial franchise fee of \$29,500 that must be paid to EOF.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least fourteen (14) calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. Note, however, that no governmental agency has verified the information contained in this document.

- 2. THE FRANCHISE AGREEMENT STATES THAT TENNESSEE LAW GOVERNS THE AGREEMENT, AND THIS LAW MAY NOT PROVIDE THE SAME PROTECTION AND BENEFITS AS LOCAL LAW. YOU MAY WANT TO COMPARE THESE LAWS.
