The franchisee will operate a business (an "Einstein Bros Restaurant") that specializes in the sale of fresh-baked bagels, cream cheese and other spreads, specialty coffees and teas, baked sweets and snacks, and creative soups, salads and sandwiches, among other things

The estimated total initial investment necessary to begin operation of an Einstein Bros Restaurant franchise ranges from \$608,300 to \$895,850 This includes \$41,000 to \$47,000 that you must pay to us before you open

If you enter into an area development agreement, the development fee will be \$10,000 for each Einstein Bros Restaurant to be opened under that agreement

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English Read this disclosure document and all accompanying agreements carefully You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale **Note, however, that no governmental agency has verified the information contained in this document**
