El Pollo Loco[®] franchisees operate quick-service restaurants that offer fire-grilled food products and related services.

The total investment necessary to begin operation of an El Pollo Loco® Restaurant under a Franchise Agreement is between \$900,000 to \$1,755,000. This includes \$40,000 that must be paid to the franchisor or affiliate. We also offer development rights for El Pollo Loco® Restaurants. The fee to enter into a Development Agreement with us is \$20,000 (or \$10,000, if within the Los Angeles ("LA") Designated Market Area ("DMA"), as defined by Nielsen Media Research, Inc. per the US Cities by Designated Market Areas Report) per restaurant to be developed, and must be paid to the franchisor or affiliate. The \$20,000 (or \$10,000, if within the LA DMA) per restaurant development fee will be credited towards the initial franchise fee for each restaurant to be developed. If you purchase an existing restaurant from us, you will pay a purchase price for the restaurant in addition to the initial franchise fee of \$40,000 that must be paid to the franchisor or affiliate. A different initial term may be offered in our discretion, such as to match your (sub)lease. In such case, the initial franchise fee will be appropriately pro-rated.

This Disclosure Document summarizes certain provisions of your franchise or development agreement and other information in plain English. Read this Disclosure Document and all accompanying agreements carefully. You must receive this Disclosure Document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no government agency has verified the information contained in this document.**

You may wish to receive your Disclosure Document in another format that is more convenient for you. THE FRANCHISE AND DEVELOPMENT AGREEMENT REQUIRE YOU TO RESOLVE DEVELOPMENT DISPUTES WITH US BY ARBITRATION AND ALL OTHER DISPUTES WITH US BY MEDIATION IN THE STATE IN WHICH OUR HEADQUARTERS IS LOCATED AT THE TIME THE ACTION IS INITIATED, CURRENTLY CALIFORNIA. OUT-OF-STATE ARBITRATION OR MEDIATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES. IT MAY ALSO COST YOU MORE TO ARBITRATE OR MEDIATE WITH US IN CALIFORNIA THAN IN YOUR OWN STATE.
- 2. THE FRANCHISE AND DEVELOPMENT AGREEMENT REQUIRE YOU TO SUE EL POLLO LOCO® ONLY IN IN THE STATE IN WHICH OUR HEADQUARTERS IS LOCATED AT THE TIME THE ACTION IS INITIATED, CURRENTLY CALIFORNIA. OUT OF STATE LITIGATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES. IT MAY ALSO COST MORE TO SUE EL POLLO LOCO® IN ORANGE COUNTY, CALIFORNIA THAN IN YOUR HOME STATE.
- 3. THE FRANCHISE AND DEVELOPMENT AGREEMENT STATES THAT CALIFORNIA LAW GOVERNS THE AGREEMENTS, AND THIS LAW MAY NOT PROVIDE THE SAME PROTECTIONS AND BENEFITS AS LOCAL LAW. YOU MAY WANT TO COMPARE THESE LAWS
- 4. EL POLLO LOCO® AND ITS AFFILIATES MAY ESTABLISH OTHER FRANCHISES, COMPANY-OWNED OUTLETS OR OTHER CHANNELS OF DISTRIBUTION, AND MAY SELL OR DISTRIBUTE ANY PRODUCT OR SERVICE TO THE GENERAL PUBLIC, UNDER THE SAME AND/OR A DIFFERENT TRADEMARK, IN COMPETITION WITH YOUR FRANCHISE.
- 5. THERE MAY BE OTHER RISKS CONCERNING THIS FRANCHISE.

Note: FRANCHISE LAWS OF YOUR STATE MAY VOID OR SUPERSEDE THE VENUE AND CHOICE OF LAW PROVISIONS OF THE FRANCHISE AGREEMENT REFERRED TO ABOVE (SEE EXHIBIT A).
