Elements Therapeutic Massage, LLC, offers franchises for the operation of studios under the name “Elements Massage” offering various forms of therapeutic massage services and any related future services and products. The total investment necessary to begin operation of an Elements Massage studio ranges from ~~\$214,800~~ 192,150 to ~~\$380,700~~ 391,050. This includes ~~\$52,074~~ 52,424 to ~~\$72,074~~ 72,424 that you must pay to us or our affiliates.
