- 4. SUBJECT TO APPLICABLE LAW, YOU MUST COMPLY WITH MAXIMUM AND MINIMUM PRICES SET BY THE FRANCHISOR FOR THE PRODUCTS AND SERVICES YOU SELL. THIS REQUIREMENT MAY REDUCE YOUR ANTICIPATED REVENUE AND NET INCOME.
- 5. THERE MAY BE OTHER RISKS CONCERNING THIS FRANCHISE.
