The franchise offered is for the establishment and operation of a business providing residential maids and cleaning services. Typically, franchisees will operate the business from a home office location and may transition into a commercial space to operate the administrative side of the business.

The estimated total investment necessary to begin operations of an eMaidS franchise is \$46,400 to \$72,500. This includes \$21,500 that must be paid to the franchisor or affiliate.

This Disclosure Document summarizes certain provisions of your franchise agreement and other information in plain English. Read this Disclosure Document and all accompanying agreements carefully. You must receive this Disclosure Document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale or grant. **Note, however, that no governmental agency has verified the information contained in this document.**
