There are two types of EMSAR® Franchises. An EMSAR® Equipment Management, Service and Repair Franchise is the right within a non-exclusive area to perform equipment management, service and repair on certain medical and related products. An EMSAR® Equipment Management and Service-Only Franchise is the right within a non-exclusive area to perform equipment management and service on certain medical and related products.

The initial Franchise Fee is \$25,000 for an Equipment Management, Service and Repair Franchise and \$10,000 for an Equipment Management and Service-Only Franchise, payable in one lump sum. The estimated initial investment for an Equipment Management, Service and Repair Franchise is approximately \$66,860 to \$73,110 and the initial investment for an Equipment Management and Service-Only Franchise is approximately \$43,240 to \$49,490.

This franchise is for the establishment and operation of an EMSAR service center performing equipment management, service and, optionally, repair, on certain medical and related products.

The total investment necessary to begin operation of an EMSAR franchise ranges from \$43,240 to \$73,110. This includes \$15,000 to \$35,000 that must be paid to the franchisor or affiliate.

This Disclosure Document summarizes certain provisions of your franchise agreement and other information in plain English. Read this Disclosure Document and all accompanying agreements carefully.
