The franchised business you will own and operate is a retail store with a special system relating to selling high-end running, triathlon, swimming and other althetic apparel, equipment and merchandise under the trade name "Endurance House"."

The total investment necessary to begin operation of an Endurance House Franchise is from  $$\frac{373,500}{376,300}$  to  $$\frac{669,500}{574,300}$ . This includes  $$\frac{29,000}{574,000}$  to  $$\frac{37,000}{32,000}$  that must be paid to us or our affiliate.

We also offer to certain qualified persons rights to develop a number of Endurance House Franchises within a given exclusive Development Area in accordance with a Development Schedule under an Endurance House Development Agreement. The Development Fee is equal to \$10,000 times the number of <a href="Franchised">Franchised</a> Outlets <a href="Gother than the first Franchised Outlet">Gother than the first Franchised Outlet</a>) you agree to open that you must pay to us. You must purchase your first Endurance House Franchise at the time you purchase Development Rights. <a href="A portion-We credit \$10,000">A portion-We credit \$10,000</a> of the Development Fee is credited against the Initial Franchise Fee for each additional Endurance House Franchise that you develop.

This Franchise Disclosure Document summarizes certain provisions of your Franchise Agreement and other information in plain English. Read this Franchise Disclosure Document and all accompanying agreements carefully. You must receive this Franchise Disclosure Document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, us or an affiliate in connection with the proposed franchise sale or grant.
