

The franchise will offer educational activities, namely, providing seminars, classes, camps, workshops, conferences, and programs in the fields of math, science, technology, and engineering, using our business system and the "Engineering For Kids" trademarks.

The estimated total investment necessary to begin operation of an Engineering For Kids franchise is \$38,175 to \$58,125 for home based business with a standard territory (or \$27,175 to \$47,125 for a home based business with a half-territory) and \$60,675 to \$93,625 for a business based at a retail "Engineering For Kids" center with a standard territory (or \$49,675 to \$82,625 for a center-based business with a half-territory). This includes \$22,500 to \$23,000 that must be paid to us if you have a standard territory, or \$11,250 to \$11,725 that must be paid to us if you have a standard territory.

This Disclosure Document summarizes certain provisions of your Franchise Agreement and other information in plain English. Read this Disclosure Document and all accompanying agreements carefully. You must receive this Disclosure Document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. Note, however, that no government agency has verified the information contained in this document.
