A Franchisee has the option of selecting one of three franchise systems. The total investment necessary to begin operation of a "**Metropolitan**" Environment Control franchise is \$70,000. This includes \$70,000 that must be paid to us or our Affiliate. The total investment necessary to begin operation of a "**Community**" Environment Control franchise is \$60,000. This includes \$60,000 that must be paid to us or our Affiliate. This includes \$50,000 that must be paid to us or our Affiliate.
