E & G Franchise Systems, Inc. (the "Company") franchises Erbert & Gerbert's Sandwich Shop® restaurants, which feature gourmet sandwiches and specialty soups to be served on the premises and for pick-up by, or delivery to, the customer.

The total investment necessary to begin operation of an Erbert and Gerbert's Sandwich Shop® restaurant is from \$189,500 to \$391,700. This includes \$32,500 to \$35,000 that must be paid to the franchisor or its affiliates. If you sign an Area Development Agreement, you will pay us a nonrefundable Territory Fee of \$10,000 times the number of restaurants you agree to develop. We will apply the \$10,000 payment against future Initial Franchise Fees for your Erbert and Gerbert's Sandwich Shop® restaurants that you develop under the Area Development Agreement.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**
