If we (franchisor) approve you (franchisee), you will have the right to establish and operate a European Wax Center business offering high-end facial and body hair removal and related skin care services to women and men predominantly through the use of hot wax, and other related products and services

The total investment necessary to begin operations of a European Wax Center® franchise is \$337,400 to \$496,916. This includes \$62,800 to \$65,416 that must be paid to us or our affiliates, which includes a one-time lump sum franchise fee of \$45,000 for your initial European Wax Center franchise, or \$36,000 for your subsequent European Wax Center franchises, that you pay to us, the franchisor. It also includes \$17,200 to \$20,416 that you pay to our affiliate, EWC Franchise Distribution, LLC, for a start-up package of your initial supply of European Wax Center products and supplies

This Disclosure Document summarizes certain provisions of your franchise agreement and other information in plain English. Read this Disclosure Document and all accompanying agreements carefully. You must receive this Disclosure Document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. Note, however, that no governmental agency has verified the information contained in this document.

MANY FRANCHISE AGREEMENTS DO NOT ALLOW YOU TO RENEW UNCONDITIONALLY AFTER THE INITIAL TERM EXPIRES YOU MAY HAVE TO SIGN A NEW AGREEMENT WITH DIFFERENT TERMS AND CONDITIONS IN ORDER TO CONTINUE TO OPERATE YOUR BUSINESS BEFORE YOU BUY, CONSIDER WHAT RIGHTS YOU HAVE TO RENEW YOUR FRANCHISE, IF ANY, AND WHAT TERMS YOU MIGHT HAVE TO ACCEPT IN ORDER TO RENEW

PLEASE CONSIDER THE FOLLOWING RISK FACTORS BEFORE YOU BUY THIS EUROPEAN WAX CENTER FRANCHISE

- THE FRANCHISE AGREEMENT REQUIRES THAT MOST DISPUTES BE SUBMITTED TO ARBITRATION IN BROWARD COUNTY, FLORIDA THE FRANCHISE AGREEMENT ALSO REQUIRES THAT EXCEPT FOR CERTAIN LIMITED CIRCUMSTANCES, ALL CLAIMS UNDER THE FRANCHISE AGREEMENT MUST BE BROUGHT IN BROWARD COUNTY, FLORIDA OR WHERE OUR PRINCIPAL OFFICE IS LOCATED, IF DIFFERENT OUT OF STATE ARBITRATION AND LITIGATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES IT MAY ALSO COST YOU MORE TO ARBITRATE AND LITIGATE WITH US IN FLORIDA THAN IN YOUR OWN STATE
- THE FRANCHISE AGREEMENT STATES THAT FLORIDA LAW GOVERNS THE FRANCHISE AGREEMENT, AND FLORIDA LAW MAY NOT PROVIDE THE SAME PROTECTIONS AND BENEFITS AS YOUR STATE'S LAW YOU MAY WANT TO COMPARE THESE LAWS
- IF THE LAWS OF YOUR STATE ALLOW US TO DO SO, WE MAY SET THE PRICE FOR THE PRODUCTS AND SERVICES YOU SELL. IF WE SET THE PRICE FOR THE PRODUCTS AND SERVICES YOU SELL, YOU MUST COMPLY WITH THESE MINIMUM AND MAXIMUM PRICES FOR THESE PRODUCTS AND SERVICES THIS REQUIREMENT MAY REDUCE YOUR ANTICIPATED REVENUE AND NET INCOME
- AS OF MARCH 4, 2015, WE AWARDED 660 EUROPEAN WAX CENTER FRANCHISE LICENSES, OF WHICH 420 ARE OPEN AND OPERATING ACCORDINGLY, ONLY 64% OF OUR LICENSES ARE OPEN AND OPERATING AS OF MARCH 4, 2015 OF THE 240 LICENSES THAT HAVE NOT YET OPENED, 55 LICENSES ARE UNDER DEVELOPMENT
- YOU AND ANY PERSON WHO OWNS MORE THAN 5% OF A FRANCHISEE ENTITY MUST SIGN A GUARANTY MAKING EACH PERSON JOINTLY AND INDEPENDENTLY LIABLE FOR THE FRANCHISEE'S FINANCIAL AND PERFORMANCE OBLIGATIONS TO THE FRANCHISOR. THE GUARANTY WILL PLACE YOUR PERSONAL ASSETS AT RISK IF YOUR FRANCHISE FAILS YOUR SPOUSE AND THE SPOUSE OF ANY PERSON WHO OWNS MORE THAN 5% OF A FRANCHISEE ENTITY MUST SIGN A JOINDER TO THIS PERSONAL GUARANTY THIS JOINDER WILL PLACE YOUR SPOUSE'S JOINTLY HELD PROPERTY AND MARITAL ASSETS AT RISK IF YOUR FRANCHISE FAILS
- MOST INVENTORY PRODUCTS, INCLUDING THE WAX USED ON THE OPERATION OF YOUR CENTER, WILL BE PURCHASED FROM OUR AFFILIATE, EWC FRANCHISE DISTRIBUTION, LLC WE AND OUR AFFILIATES SET THE COST OF THESE PRODUCTS BASED ON A NUMBER OF FACTORS, INCLUDING OUR COSTS IN OBTAINING THESE PRODUCTS FROM THE MANUFACTURER DUE TO THE NATURE
