The franchisee will establish and operate a hotel under the EVEN® Hotels brand.

The total investment necessary to begin operation of a typical 132-room hotel under the EVEN[®] Hotels brand, excluding land costs, inestimable items and contingency funds, ranges from \$12,011,135 to \$19,247,895 (\$90,993.45 to \$145,817.39 per guest room) or more (see Item 7), including between \$171,385 and \$202,195 or more that must be paid to the franchisor or an affiliate (see Item 5).

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**
