The franchise offered is for the operation of a travel agency business that offers reservations for cruise ships, airlines, car rentals and hotels, as well as other related travel services and products.

The total estimated investment required to begin operation of an Expedia[®] CruiseShipCenters[®] franchised travel business ranges from \$155,850 to \$275,945 including \$39,000 that must be paid to us as a non-refundable initial fee.
