

## **Franchise Disclosure Document**

The franchisee will own and operate an Experimax® franchise which operates a retail business buying, selling, repairing and refurbishing used cell phones, computers, tablets and other electronic equipment.

The total investment necessary to begin operation of an Experimax® store is from \$139,460 to \$351,140. These amounts include \$64,500 to \$92,000 that must be paid to the franchisor or an affiliate if you obtain financing for the purchase of your equipment to \$134,400 to \$186,900 that must be paid to the franchisor or an affiliate if you purchase your equipment.

The disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**

The terms of your contract will govern your franchise relationship. Do not rely on the disclosure document alone to understand your contract. Read all of your contract carefully. Show your contract and this disclosure document to an advisor, such as a lawyer or accountant.

Buying a franchise is a complex investment. The information in this disclosure document can help you make up your mind. Here are some questions you may be asking about buying a franchise and tips on how to find more information:

| How much can I earn?  | Item 19 may give you information about outlet sales,<br>costs, profits or losses. You should also try to obtain this<br>information from others, like current and former<br>franchisees. You can find their names and contact<br>information in Item 20 or Exhibits K and L. |
| How much will I need to invest?   | Items 5 and 6 list fees you will be paying to the<br>franchisor or at the franchisor's direction. Item 7 lists<br>the initial investment to open. Item 8 describes the<br>suppliers you must use.  |
| Does the franchisor have the financial<br>ability to provide support to my<br>business? | Item 21 or Exhibit D includes financial statements.<br>Review these statements carefully.  |
| Is the franchise system stable, growing, or shrinking?                                  | Item 20 summarizes the recent history of the number of company-owned and franchised outlets.   |
| Will my business be the only Experimax<br>in my area?                                   | Item 12 and the "territory" provisions in the franchise agreement describe whether the franchisor and other franchisees can compete with you.  |
| Does the franchisor have a troubled legal history?                                      | Items 3 and 4 tell you whether the franchisor or its management have been involved in material litigation or bankruptcy proceedings.   |
| What's it like to be an Experimax<br>franchisee?  | Item 20 or Exhibits K and L list current and former franchisees. You can contact them to ask about their experiences.  |
