The franchise offered is for an Express Oil Change or Express Oil Change/Tire Engineers Center (“Center”) specializing in quick oil change and lubrication, transmission service, air conditioning service, brake repair, tune-ups, and tire ~~rotation and balance~~sales and service.

The total investment necessary to begin operation of an ~~Express Oil Change franchise~~ Center is ~~\$1,400,500~~\$1,425,500 - ~~\$1,883,500~~\$2,063,500. This includes ~~an initial fee of~~ \$35,000 ~~for your first Center and \$17,500 for any additional Center~~ that must be paid to the franchisor or ~~its~~ affiliate(s). If you sign an Area Development Agreement to develop a number of Centers, you must pay us a development fee of \$35,000 for your first Center and a non-refundable deposit of \$7,500 for each additional Center to be developed.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**

The terms of your contract will govern your franchise relationship. Do not rely on the disclosure document alone to understand your contract. Read all of your contract carefully. Show your contract and this disclosure document to an advisor, like a lawyer or an accountant.
