The franchise offered is to operate a fitness center with minimal overhead and labor cost. You will generally pay an initial franchise fee of \$10,000. The fee is the same if you are converting an existing health club or if you are installing an Extreme Gym franchise in a hotel, motel or apartment complex that you own or operate. However, if you already own at least one Extreme Gym franchise and you are not in default under the existing franchise agreement with us, the fee is reduced.

- (1) The total investment necessary to begin operation of an Extreme Gym franchise is \$46,599 \$62,991. Our estimate include the total cost for equipment and assumes that you lease your space for \$2000 monthly or less and operate your center yourself without employees. The estimate also includes fees for security system, access cards, digital video recorder, 24 hour keyless entry system that must be paid to us the franchisor or our affiliates.
- (2) This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document**.

- (3) The terms of your contract will govern your franchise relationship. Don't rely on the disclosure document alone to understand your contract. Read your entire contract carefully. Show your contract and this disclosure document to an advisor, like a lawyer or an accountant.
