We offer a franchise to operate a learning center under the "Eye Level Learning Center" name. The learning center offers methods and programs for mathematics, English and other academic curricula to pre-school up to high-school students.

The estimated total investment necessary to begin operation of an Eye Level Learning Center ranges from \$75,588 to \$139,050. This includes the initial franchise fee of \$20,000 and other fees of \$5,000 which must be remitted to us or to our affiliates. The total investment necessary under the Area Development Agreement equals \$10,000 multiplied by the total number of Eye Level Learning Centers to be developed. This amount is payable to us. We credit the initial development fee against the initial franchise fee for each Eye Level Learning Center (after the first one).

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**
