You will operate a business offering same day delivery service of dry ice, x-rays, legal documents, lab specimens, and medical or time-sensitive documents and specializing in the handling, packaging and shipping of infectious and diagnostic medical lab specimens including organ donor pick up and delivery to the proper facility for testing and delivery to the proper hospital. We also provide pickup and delivery services for churches, banks, credit unions, pharmacies and other businesses.

The initial franchise fee is \$35,000. The estimated initial investment ranges from \$119,075 to \$161,392.

#### RISK FACTORS:

1. THE FRANCHISE AGREEMENT REQUIRES THAT CERTAIN DISAGREEMENTS BE LITIGATED IN SAGINAW COUNTY, MICHIGAN. OUT OF STATE LITIGATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES. IT MAY ALSO COST YOU MORE TO LITIGATE WITH US IN MICHIGAN THAN IN YOUR HOME STATE.

2. THE FRANCHISE AGREEMENT STATES THAT MICHIGAN LAW GOVERNS THE AGREEMENT; HOWEVER, MICHIGAN LAW MAY NOT PROVIDE THE SAME PROTECTIONS AND BENEFITS AS YOUR STATE'S LAW. YOU MAY WANT TO COMPARE THESE LAWS. SOME STATE FRANCHISE LAWS PROVIDE THAT CHOICE OF LAW PROVISIONS ARE VOID OR SUPERSEDED. YOU MIGHT WANT TO INVESTIGATE WHETHER YOUR STATE HAS FRANCHISE LAWS THAT PROTECT YOU. YOU SHOULD REVIEW THE ADDENDA ATTACHED TO THIS OFFERING CIRCULAR AND THE FRANCHISE AGREEMENT FOR STATE-SPECIFIC PROVISIONS.

3. THERE MAY BE OTHER RISKS CONCERNING THIS FRANCHISE.
