As a franchisee, you will operate a retail walk up and drive through fast-food restaurant that specializes in hamburgers, french fries, soft drinks, milk shakes, other food products, other beverages and related products under the EZ Take Out Burger trademark and system of operating procedures. The total investment necessary for you to begin operating an EZ Take Out Burger restaurant ranges from \$97,000 to \$401,600. This includes \$25,000 that must be paid to EZTO.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar_-days before you sign a binding agreement with, or make any payment to, the Franchisor or an affiliate in connection with the proposed franchise sale. Note, however, that no government agency has verified the information contained in this document.
