Family Fare

Franchisee will operate an extended-hour retail convenience store under the tradename and service mark "FAMILY FARE" which sells fuel, groceries, take-out foods and beverages, dairy products, non-food merchandise, specialty items and selected services. FAMILY FARE, LLC provides services to Franchisees including assistance with training, operations, advertising, purchasing and promotional techniques.

The total investment necessary to begin operation of a Family Fare franchise is between \$33,300 and \$631,200. This includes between \$16,000 and \$510,000 that must be paid to us or an affiliate.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to, us or an affiliate in connection with the proposed franchise sale. Note, however, that no governmental agency has verified the information contained in this document.
