Family Doctor Plus, LLC offers franchises to licensed physicians for urgent care clinics that will offer various levels of medical and health care-related services and the equipment and supplies required to provide the services to patients under the trade name "Family MED Plus" and other related trademarks, service marks, logos and commercial symbols We offer 2 franchise programs in this Disclosure Document

**Single Clinic Program** Under this program, you will operate one Family MED Plus Clinic from a location that you select The total investment necessary to begin operation of a Family MED Plus Clinic is \$230,500 to \$1,166,000 This includes \$55,000 that must be paid to us or our affiliate

**Area Development Program** Under this program, you will agree to open and operate 2 – 3 Family MED Plus Clinics in a defined geographic area within a specified period of time The total investment necessary to begin operation of an area development franchise for 2 – 3 Family MED Plus Clinics is approximately \$252,500 to \$1,199,000 This includes \$75,000 to \$85,000 that must be paid to us or our affiliate

This Disclosure Document summarizes certain provisions of your franchise agreement and other information in plain English Read this Disclosure Document and all accompanying agreements carefully You must receive this Disclosure Document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the Franchisor or an affiliate in connection with the proposed franchise sale **Note, however, that no governmental agency has recommended or verified the information contained in this Disclosure Document**

The Payment Card Industry Data Security Standard ( 'PCI DSS') requires all companies that process, store or transmit credit or debit card information to maintain a secure environment PCI DSS applies to all organizations or merchants, regardless of size or number of transactions, that accepts, transmits or stores any cardholder data

### **Legal Review and Compliance**

Before you sign your Franchise Agreement, you must obtain and deliver to us from an attorney you select who is satisfactory to us and is licensed to practice law in the state in which your Family MED Plus Clinic will be located, a written opinion (the "Legal Opinion") addressing (i) whether your prospective operation of your Family MED Plus Clinic in accordance with the terms of our Franchise Agreement complies with applicable law (including laws regarding corporate practice of medicine, fee splitting and health care rules and regulations), and (ii) the agreement and operational modifications necessary, if any, for compliance The Legal Opinion must also address other related issues we may designate periodically in our Administrative Manual or otherwise in writing Immediately upon request, you must obtain from your attorney additional legal opinions we may request, regarding the above (these additional opinions are also included within the definition of "Legal Opinion" ) If the Legal Opinion concludes that it is impossible for you to operate the Family MED Plus Clinic in compliance with applicable law, or if we conclude that the agreement and operational modifications necessary for such compliance are impractical, we may terminate this Agreement immediately upon written notice to you If we conclude that the agreement and operational modifications necessary, if any, for compliance are practical, we will have the right to modify the Franchise Agreement and make operational modifications immediately on written notice to you

Without limiting your obligations under your Franchise Agreement to comply with applicable law, you must ensure that your operation of your Family MED Plus Clinic and your relationship with your Physicians and all nurses, physician assistants, and other medical professionals and the manner in which your Family MED Plus Clinic provides services comply with all applicable rules, regulations, ordinances and standards of professional conduct We have the right to require you to restructure your compensation arrangements with us in order to comply with applicable law You must take all measures we prescribe in the Administrative Manual or otherwise in writing to inform all individuals associated with and potential Patients of the Family MED Plus Clinic that we have no control over or responsibility for any person's or persons practice of medicine or any other practice of a profession
