FasTrackKids International, Ltd., a Colorado corporation, is offering franchises for the operation of businesses that offer enrichment education courses for children from 6 months to 8 years of age, or up to 15 years of age in the case of certain optional courses, through a technologically advanced curriculum and delivery system.

The total investment necessary to begin operation of a FasTrackKids Enrichment Center franchise is from \$47,135 to \$185,220. This includes \$33,635 to \$55,820 that must be paid to the franchisor or affiliate (representing the initial fees and payments for goods and services which you are required to purchase from us). The franchisor may offer to qualified candidates the right to develop multiple FasTrackKids Enrichment Centers under the terms of a Multi-Unit Development Agreement, in which case the total investment stated above will increase by an amount equal to \$8,000 times the number of additional FasTrackKids Enrichment Center to be developed under the Multi-Unit Development Agreement, which amounts are paid to the franchisor.

This Disclosure Document summarizes certain provisions of your Franchise Agreement and other information in plain English. Read this Disclosure Document and all accompanying agreements carefully. You must receive this Disclosure Document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**

OUT-OF-STATE ARBITRATION OR LITIGATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES. IT MAY ALSO COST YOU MORE TO ARBITRATE OR LITIGATE WITH US IN COLORADO THAN IN YOUR OWN STATE.

2. THE FRANCHISE AGREEMENT AND DEVELOPMENT AGREEMENT STATE THAT COLORADO LAW GOVERNS EACH AGREEMENT, AND THIS LAW MAY NOT PROVIDE THE SAME PROTECTIONS AND BENEFITS AS LOCAL LAW. YOU MAY WANT TO COMPARE THESE LAWS.

3. BY OWNING A FRANCHISE YOU ARE GOING INTO BUSINESS FOR YOURSELF. IT CARRIES WITH IT THE INHERENT RISKS OF OWNING A BUSINESS GENERALLY. IF YOU ACQUIRE A FRANCHISE, YOU MUST ASSUME THE RISK THAT YOU COULD LOSE YOUR ENTIRE INVESTMENT.

4. THERE MAY BE OTHER RISKS CONCERNING THIS FRANCHISE.
