The total investment necessary to begin operation of a Fava Tea store is from \$126,825 to \$349,150. This includes the \$35,000 to \$45,000 initial fees that must be paid to the franchisor or its affiliates.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully.
