The total investment necessary to begin operation of a FIRE+ICE franchised Restaurant is \$1,125,000 to \$3,463,950. This includes a \$25,000 deposit with the balance due when the Franchise Agreement is executed (\$35,000) that must be paid to the franchisor or its affiliate(s).

If You are an Area Developer, You are required to pay Us a nonrefundable Development Fee equal to the Initial Franchise Fee for the first Required Restaurant plus \$18,000 for each additional Required Restaurant.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no government agency has verified the information contained in this document.**
