Fireline Range Development, LLC is offering franchises for the operation under the Fireline Shooting & Training service mark of a shooting sports center featuring an indoor shooting range, a training center providing proprietary training classes on various firearm and safety related topics, and a retail store component selling firearms and related accessories, ammunition and reloading equipment.

The total investment necessary to begin operation of a 10-16 lane Fireline Shooting & Training shooting sports center ranges from \$2,006,400 to \$4,423,200, excluding real estate. This includes \$35,000 that must be paid to the franchisor.

This Disclosure Document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**
