You will operate a restaurant featuring Neapolitan style signature and create-your-own pizzas, as well as salads, Italian gelato, soft drinks and related items under the name FIRO.

The total investment necessary to begin operation of a FIRO franchised business ranges from \$489,000 to \$897,000. This includes \$40,000 that must be paid to the franchisor or its affiliate(s). If you are acquiring development rights under a development program, you will sign a development agreement and pay a development fee equal to 100% of the initial franchise fee for the first restaurant (\$40,000), plus 50% of the initial franchise fee for each additional restaurant be developed (where 50% of the initial franchise fee for the additional restaurants is equal to \$17,500 each).

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. Note, however, that no governmental agency has verified the information contained in this document.
