

Commissioner of Commerce Glenn Wilson has determined as follows:


1. Respondent's franchise registration was suspended on July 1, 2008.

Commissioner of Commerce Glem Wilson (hereinafter "Commissioner") has determined as follows:

1. Respondent's franchise registration was effective immediately prior to July 1, 2008.
2. Respondent's franchise registration application was prepared in accordance with the Uniform Franchise Offering Circular ("UFOC") Guidelines adopted by the North American Securities Administrators Association ("NASAA"). Minn. Rules 2860.3800 (2005).
3. In March 2007, the Federal Trade Commission ("FTC") amended its Trade Regulation Rule entitled "Disclosure Requirements and Prohibitions Concerning Franchising and Business Opportunity Ventures" ("2007 Franchise Rule"). 72 Fed. Reg. 15,444 (Mar. 30, 2007) (codified at 16 C.F.R. pt. 436).
