The franchisee will receive a franchise and license to own and operate a FustLight HomeCare business, providing non-medical care services to individuals 18 years of age or older, needing assistance with the activities of daily living and personal care, as well as those requiring companion care and dementia care, for an initial term of 10 years with the right, on payment of a renewal fee and compliance with other conditions, to renew for 2 additional successive 10 year renewal terms

The total investment necessary to begin operation of a FirstLight HomeCare franchise ranges from $\$70.146\underline{85,281}$ to $\$99.889.12\underline{8,659}$.
