As a Fit Body Boot Camp franchisee you will operate a retail outlet providing group personal training and fitness services to retail customers using designated or authorized "Fit Body Boot Camp" fitness programs and methods.

The total investment necessary to begin operation of a Fit Body Boot Camp outlet ranges from \$27,747 to as much as \$85,491. This includes \$9,997 that must be paid to the franchisor or affiliate when our initial obligations to you under the Franchise Agreement are complete and you are open for business. FBBC may also offer you a Multi Outlet Agreement granting a right to open one or more additional Outlets for an additional investment ranging from \$4,998.50 to \$19,994 (for multiple locations), all of which must be paid to the franchisor.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note**, **however**, **that no governmental agency has verified the information contained in this document.**

OUT-OF-STATE LITIGATION OR ARBITRATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES. IT MAY ALSO COST MORE TO SUE OR ARBITRATE WITH US IN CALIFORNIA THAN IN YOUR OWN STATE.
- 2. THE FRANCHISOR HAS BEEN IN EXISTENCE FOR A SHORT PERIOD OF TIME, SINCE MARCH 2, 2011. THEREFORE, THERE IS ONLY A BRIEF OPERATING HISTORY TO ASSIST YOU IN JUDGING WHETHER OR NOT TO MAKE THIS INVESTMENT.
- 3. IN ITS LAST FISCAL YEAR ENDING DECEMBER 31, 2013, THE FRANCHISOR EXPERIENCED A NET LOSS OF \$169,041 AND AS OF DECEMBER 31, 2013, THE FRANCHISOR HAD ONLY \$74,272 IN ASSETS.
- 4. THE FRANCHISE AGREEMENT STATES THAT CALIFORNIA LAW GOVERNS THE AGREEMENT, AND THIS LAW MAY NOT PROVIDE THE SAME PROTECTIONS AND BENEFITS AS LOCAL LAW. YOU MAY WANT TO COMPARE THESE LAWS.
- 5. THERE MAY BE OTHER RISKS CONCERNING THIS FRANCHISE.
