The total investment necessary to begin operation of a Fit Body Boot Camp outlet is \$37,650 to \$87,500 This includes \$18,750 to \$25,000 which must be paid to the franchisor or its affiliates FBBC may also offer you an Area Development Agreement granting a right to open one or more additional Outlets for an additional investment (Development Fee) of \$9,375 to \$12,500 for each additional Outlet you commit to open, which must be paid to the franchisor
