# **FIT BODY BOOT CAMP**

As a Fit Body Boot Camp franchisee, you will operate a retail outlet providing group personal training and fitness services to retail customers using designated or authorized "Fit Body Boot Camp" fitness programs and methods.

The total investment necessary to begin operation of a Fit Body Boot Camp outlet is \$39,525 to \$90,000. This includes \$20,625 to \$27,500 which must be paid to the franchisor or its affiliates. FBBC may also offer you an Area Development Agreement granting a right to open one or more additional Outlets for an additional investment (Development Fee) of \$13,750 for each additional Outlet you commit to open, which must be paid to the franchisor.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**
