FIT BODY BOOT CAMP

As a Fit Body Boot Camp franchisee you will operate a retail outlet providing group personal training and fitness services to retail customers using designated or authorized "Fit Body Boot Camp" fitness programs and methods.

The total investment necessary to begin operation of a single Fit Body Boot Camp outlet is \$151,100 to \$213,100. This includes \$49,600 which must be paid to the franchisor or its affiliates.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**
