We offer for sale a franchise that enables you to conduct sports, fitness and recreation programs, including classes and leagues, for elementary and middle school aged children in facilities provided by schools or organizations that desire to make such programs available. Payment for participation in the programs may be paid by schools, organizations or by participants. Fit Kids America Franchising, LLC, may sell equipment, uniforms or supplies to you at reasonable prices.

The total investment necessary to begin operation of a Fit Kids America™ franchised business ranges from \$6,455 to \$39,850. This amount includes an Initial Franchise Fee ranging from \$5,000 to \$30,000, which must be paid to the Franchisor, and an estimated \$150 to \$1200 for opening inventory and apparel which must be paid to the Franchisor or an Affiliate. The amount of the Initial Franchise Fee will differ based on the number of schools in your territory.

This disclosure document summarizes certain provisions of the franchise agreement and other information in plain English. Read this disclosure document and all agreements carefully. You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or any affiliate in connection with the proposed franchise sale. You must also receive completed copies of all contracts at least five days before you sign them. **Note, however, that no governmental agency has verified the information contained in this document.**

OUT OF STATE ARBITRATION OR LITIGATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES. IT MAY ALSO COST MORE TO ARBITRATE OR LITIGATE WITH FIT KIDS AMERICA FRANCHISING, LLC, IN SAN DIEGO COUNTY, CALIFORNIA THAN IN YOUR HOME STATE. THIS MAY BE SUPERSEDED BY STATE LAW.
