The franchise offered is for the right to operate a school under the name "The Florence Melton Adult Mini-School" or "The Florence Melton School of Adult Jewish Learning" that teaches core Jewish knowledge to adults.

The total investment necessary to begin operation of a School offering the core curriculum is \$46,000 to \$82,900. This includes \$6,500 to \$15,320 that must be paid to the franchisor or affiliate. The total investment necessary to begin operation of a School offering only the scholars curriculum is \$4,460 to \$15,720. This includes \$2,360 that must be paid to the franchisor or affiliate. The total investment necessary to begin operation of a School offering only the foundations course is \$4,460 to \$15,720. This includes \$2,360 that must be paid to the franchisor or affiliate.

This Disclosure Document summarizes certain provisions of your franchise agreement and other information in plain English. Read this Disclosure Document and all accompanying agreements carefully. You must receive this Disclosure Document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale.
